## Areas of Interest:

The mission of the Huey and Angelina Wilson Foundation is to enhance Louisiana's communities, in particular the greater Baton Rouge area, by supporting philanthropic initiatives and programs that improve the lives of its citizens.

The Foundation's present areas of focus include:

- human services, including homelessness, hunger, drug rehabilitation, youth, the disabled, and the ill;
- healthcare, including providing access to care, education, and prevention services and projects that serve the working poor, the indigent, and those with little or no insurance;
- education, including charter schools, alternative schools, early learning, out-of-school-time programming, and literacy for both adults and overaged students; and,
- prison reentry, including projects that create a continuum of care, including education, job readiness, life and soft skills training, financial literacy, parenting, family reunification, and efforts to integrate "smart on crime" principles.

Of particular interest to the Foundation are the handicapped, both physically and mentally, those afflicted with disease, disadvantaged youth, and the hungry and homeless.

The Foundation provides grants through three main programs:

- Equip Grants, which invest in capacity-building efforts to strengthen nonprofits in the ten-parish greater Baton Rouge area;
- Engage Grants, which focus on the most underserved populations in the ten-parish greater Baton Rouge area with goals to decrease the percentage of families who are liquid-asset poor, increase healthcare utilization by families below the ALICE threshold, and decrease the recidivism rate; and,
- Empower Grants, which invest in the most under-resourced north Baton Rouge neighborhoods, with a focus on housing, education, community wellness, and economic vitality.

The Foundation gives preference to projects that build on strengths and assets of individuals, organizations, and institutions and that address the underlying causes of the problems presented rather than treating symptoms.

The Foundation focuses its support on capacity building. Additional types of support include:

- program grants for new, creative, or beneficial programs, including staff salaries and benefits, supplies, equipment, travel, office leases, utilities, and training;
- capital grants, including new construction, major renovation, the purchase of permanent assets, phone systems, computers, technology upgrading, and vans or buses; and,
- bridge grants, which help mature organizations through times of economic hardship.

The Foundation does not provide seed money for new organizations, or fund endowments.

Support is available through the following programs:

## Ayuda Fund

This fund provides grants to Latino-led and serving nonprofit organizations that address critical community needs and advance social change across the state. These investments build the capacity of leadership, nonprofits, and communities that align with the Foundation's values of generational well-being, community leadership, and cultural justice.

The grant priorities of the Ayuda Fund are:

- support for historically underserved and under-resourced communities in rural, suburban, and urban areas; and,
- Latino-led organizations as reflected by the following criteria: Executive Director or CEO is Latino/a, at least 51% of the management team is Latino/a, and at least 51% of the board are Latinos/as.

## Colorado Communities of Color Loan Fund

This fund provides loans between 0% and 2% interest in amounts no less than \$10,000 and no more than \$250,000, with a one- to five-year payoff period.

Funding from the Loan Fund may be used for:

- cash flow needs related to reimbursement contracts.
- social enterprise launch or expansion; and,
- capital investments or improvements.

The Loan Fund is open to organizations that serve a population that is 66% or more communities of color and that work in the following fields:

- human services;
- workforce development;
- education;
- health;
- early childhood education;
- the environment;
- food justice; and,
- arts and culture.

## **Restrictions Details:**

The Foundation does not provide funding for special events, scholarships or individuals, or capital campaigns.
